Avoiding Disasters at Annual Meetings



Conducting successful annual association meetings is of critical importance to community associations. Community association managers and Boards



of Directors must be familiar with the procedures and legal requirements involved in calling and holding such meetings. This seminar will focus on, among other things, the following particular issues and topics:

- ♦ Steps to be taken before, during, and after annual association meetings.

- Tips on how to manage *Points of Order* and deal with unruly individuals.
- Issues that commonly arise in connection with the removal of directors.
- Issues relating to voting, "oops" we counted wrong.
