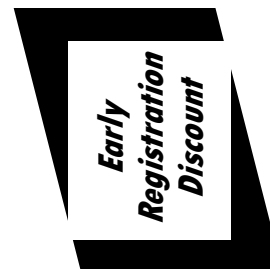

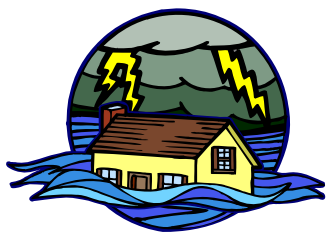

## Speakers

**Philip D. Haisley Jr., Arch.D., AIA** – Mr. Haisley is the Vice President of Architectural Diagnostics Ltd (ADL), a Honolulu based firm that specializes in analyzing and correcting construction defects and resolving water intrusion problems. He has worked on numerous microbial investigation and remediation projects that include the full range of building types, problem causes, repair value, and project complexity. He further developed this area of interest while earning his Architecture Doctorate degree, with studies including health effects of mold exposure, mycology, air quality investigation procedures, and building envelope analysis and design. His doctoral thesis project was titled “Field Inspection Protocol for Investigation of Mold Damaged Buildings”, where he developed standardized procedures for building investigations.

**Kevin L. Quinn, M.P.H., C.I.H., C.S.P.** – Mr. Quinn is the Vice President of Quinn Consultants, Inc. Mr. Quinn has approximately 18 years of industrial hygiene and health and safety experience in Hawaii, the Pacific Rim, the continental United States and around the world. He has provided certified industrial hygienist and certified safety professional services for hundreds of indoor air quality and mold abatement projects ranging from multi-million dollar fire and hurricane-damage restoration efforts to workmen’s compensation claims. In addition, he has provided health and safety oversight for several multi-year, multi-million dollar asbestos and lead abatement projects involving 10,000 plus Navy and Army housing units. He also has extensive background conducting industrial hygiene investigations and assisting in arbitration/litigation.

**Terrance M. Revere, Esq.** – Mr. Revere is a partner in the firm of Motooka Yamamoto & Revere and his practice is devoted primarily to civil litigation focusing on disputes involving community associations, insurance, commercial transactions, and torts. He is involved in community association cases involving mold, directors’ and officers’ insurance coverage, covenant enforcement, construction defects, and disputes with owners. Mr. Revere was a member of the Board of Directors of the CAI Hawaii Chapter, and he has served as Co-Chair of the Programs Committee for the past five years.
